Payment Schedule Options

The following payment schedule options are applicable for academic year:

(A) One Payment Plan

Jul 1 (6% discount)

(B) Bi-Annual Payment Plan

Jul 1 & Jan 1 (3% discount)

(C) 11 Month Payment Plan

Jul 1 through May 1

To receive the above discounts, payments must be made on the scheduled date.

Note: Withdrawal at any point will result in the removal of all pre-pay discounts. The amount of the discount will be owed upon withdrawal.

Payments in all plans are due in the office on the 1st of each month and a **late charge of \$25** may be applied to the account if payment is not received by the 15th of the month. If a tuition account becomes 60 days delinquent, the child or children may be removed from the school until the delinquent amount is paid in full or arrangements are made to pay. **Delinquent accounts will be required to be placed on autopay at the amount determined by the KCA board.** If arrangements are made and the agreed upon arrangements are broken, the child or children will be removed from school. In addition, report cards and transcripts may be withheld until full payment is rendered.

Refer-a-Family

King's Christian Academy is offering an incentive referral program to existing KCA families: Existing KCA families (A/Rs) can refer the families of non-KCA students to attend KCA. For every successful referral (where the student or students of the family referred begin to attend KCA), there will be a total of a \$100 annual tuition credit given to the referring family. We value your support- you are an essential part of growing the KCA mission!

Help us get the word out about KCA and how God is working here at KCA!

Refer-a-Family Information:

Each family referral that results in a student (or students) from the referred family attending KCA will result in a \$10 credit per month (for up to 10 months) to the referring family for each month that the referred family attends. Please note: If you pay your tuition up front, the credit can still only be applied monthly. The credit will end if the referred student stops attending KCA. If you refer a family and they have one or more students who attend, the \$100 credit can only apply once.

You can only apply the \$100 credit to one student account that you are the A/R of.

Staff of KCA are unable to participate in this referral program.

KCA Administration will alert families when they reach the maximum credit allowed; credits cannot exceed the total amount of tuition a family owes. KCA may opt to end this program (this will not stop credits already being awarded) or make changes as administration determines need.

Re-enrollment

Re-enrollment for all current students of KCA begins on the first day of February. Re-enrollment fees are as follows:

- Prior to March 1st = \$50 per student
- After March 1st = \$150 per student

We acknowledge and agree that KCA reserves the right, at its sole discretion, to refuse to re-enroll or discontinue the enrollment of our child(ren) should a determination be made that we have failed to abide by the family agreement or are otherwise demonstrating an inability to cooperate with KCA. We acknowledge that continued enrollment is contingent upon our conduct, cooperation, and faithfulness to the mission of the school.

Scholarships

We are grateful for the opportunity to extend additional options for scholarship for the 25-26 school year for through the Renewanation (RAN) EISTC scholarship. Students who are entering Kindergarten, 1st grade, who received RAN previously (at KCA in the 22-23 school year OR at another private school during the 24-25 school year) can apply. Eligibility is determined by a number of factors include the above and along with financial eligibility and a completed application. Applications can be made only by students who are enrolled at KCA and who have fully paid the application and curricular fee. Applications must be submitted by all families who receive a discount of any kind at KCA, regardless of financial eligibility. Applications will be due by no later than July 31st. Awards are not provided until approximately October. Awards are not guaranteed and amounts vary based on the algorithm used by RAN.

If you receive a KCA discount for any reason, you will be required to apply for the Renewanation (RAN) scholarship. Any amount awarded by RAN in excess of the discount awarded by KCA will be applied (excess over awarded discount amount) to my account. Any award by RAN at or below the KCA discounted amount will not be applied to my account, but will cover the awarded discount.

EXAMPLE: If you receive a \$1000 KCA discount and a \$1500 RAN award, your KCA discount will be removed and \$1500 applied to your account (cannot be taken out as a credit). If you received \$1000 from KCA discount and \$500 from RAN, your KCA discount will be adjusted to \$500 and the \$500 RAN amount applied (for a total discount of \$1000).

Withdrawal

In in all cases of withdrawal, whether voluntary, involuntary, or otherwise, families are responsible for the entire month's tuition that withdrawal occurs and \$600 per student, along with any late fees and any unpaid

balance on the account (including, but not limited to: before/aftercare fees, uniform purchases, field trips, etc.), and that I am agreeing to pay those fees, along with the full account balance, at the time my child leaves. If there is an outstanding tuition balance, transcripts, diploma(s), and final report cards will be withheld until all payments have been reconciled. Withdrawal at any point will result in the removal of all pre-pay discounts. The amount of the discount will be owed upon withdrawal.
